## Section 6: Accidental Release Measures

**PERSONAL PRECAUTIONS:** Keep unnecessary personnel away. Keep people away from and upwind of spill/leak. Keep out of low areas. Eliminate all ignition sources (no smoking, flares, sparks or flames in immediate area). Wear appropriate protective equipment and clothing during clean-up. Do not breathe mist or vapor. # Section 7: Handling and Storage


